U.S. SENATOR RANDOLPH TO SPEAK AT SIXTH ANNUAL ASHE CONVENTION

Plans are shaping up rapidly for the sixth annual convention of the American Society of Highway Engineers to be held at the Bellevue Stratford Hotel, Philadelphia, on Saturday, May 25, it was announced by John H. Leapson, P.E., general chairman of the convention committee and president of the Delaware Valley Section of ASHE.

ASHE members will receive a packet of information shortly about the convention, containing reservation forms, hotel room reservation cards, details about registration and hotel costs, and the program. Meanwhile, members are urged to mark the date of May 25 on their calenders and reserve it.



Featured speaker at the noon luncheon will be nationally known U.S. Senator Jennings Randolph, of West Virginia, who is chairman of the Public Works Committee of the Senate, and in great demand as a speaker.

Another highlight of the luncheon meeting will be the presentation of honorary membership in the American Society of Highway Engineers to the Hon. Robert G. Bartlett, Secretary of Highways of the Commonwealth of Pennsylvania, by James R. Barnicle, P.E., President of ASHE.

Senator Randolph, as chairman of the Senate Public Works Committee, has been actively interested in the nation's interstate highway construction program and is enthusiastically opposed to federal aid cut backs in the financing of this program.

He was first elected to the House of Representatives to serve in the seventy-third Congress and reelected six consecutive terms. In 1958 he was elected to the U.S. Senate and has served continuously therein; his present term will expire in 1973.

He is a former newspaper and magazine editor, former college professor and university dean; former airline executive and transportation officer; he is a member and

For a year he was engaged in highway construction as an engineer with the Alaska Road Commission, and subsequently worked as civil engineer for materials for the J. E. Griener Co., of Baltimore, materials consultant with Miller-Warden Associates, of Raleigh, N. C., and as area engineer for Alexander Construction Co., Inc. of Chester, Penna.

President's Message

I believe it was said by a philosophic rear chainman, as he and his survey crew laid the preliminary line for the first four-line dinosaur trail, that "The road to Hades is paved with good intentions". Ancient as it is, the quote is just as true to-day. None of us are immune from the im-

plications of this quotation.

Another year has been added to the ten-year life span of A. S. H. E. I feel much has been accomplished. A new constitution has just been completed and adopted. We have again, along with our bigger brothers, the A.P.C. and A.R.B.A. and their friends, jousted with the dragon of a federal cut-back of funds and other highway industry problems. Our numbers have grown, not spectacularly, but steadily. Our scattered sections have gone through their shake-down cruises, are in good hands, with good officers, active members and solid programs.

However, there are important other things, often talked about, that are still to be accomplished. With only one section beyond the confines of the State of Pennsylvania-this one in a neighbor state, at Charleston, W. Va.,—we have yet to establish ourselves as a truly national organization. This can only be accomplished by time and effort on the part of anyone and everyone in the organization having contact with interested parties in other areas. Many of you in positions of influence have those contacts in the normal course of your business, any one of which could possibly be extended into an opportunity for germinating another section if an effort were made in this regard. Perhaps the chance conversation that you have with an interested individual in such a situation could be the spark that starts another section. I'm quite sure that assistance on a national level would be immediately forthcoming if brought to their attention.

The past year has gone swiftly by with many fruitful experiences for me. Many of these have been through my association with A.S.H.E. and my present office. I have come to understand the complexity of our industry just a little better and have been provided opportunity to gain an insight into the unique problems which we alone are heir to. Technical Cross Section

PAVEMENT SKID RESISTANCE

"Tentative Skid-Resistance requirements for main rural highways," National Cooperative Highway Research Program report No. 37, 80 pages is available from the Highway Research Board, 2101 Constitution Avenue, N. W., Washington, D.C. 20418 for \$3.60.

After reviewing past research and experience in pavement skid resistance, Pennsylvania State University researchers have recommended that pavement designers use a "skid number" of 37 as the tentative minimum requirement for pavement friction on main rural highways.

H. W. Kummer and W. E. Meyer, both in the University's department of mechanical engineering, make their recommendation in this new book which is the final report on a study of pavement skid resistance conducted under the Highway Research Board-administered NCHRP.

Kummer and Meyer define the "skid number" as the friction coefficient of a tire sliding on a wet pavement times 100. The number, say the researchers, "is that measured with a skid trailer in accordance with ASTM Method E-274 at 40 mph in the most polished track of the road (usually the left wheel track of the traffic lane) during the summer or fall."

For high speed roads, the researchers explicitly recommend higher skid numbers (as measured at 40 mph) to compensate for the reduction of friction between tire and wet pavement that accompanies higher speeds.

In the foreword to the new book, NCHRP staff engineers stress the fact that the recommended minimum skid number is both *minimum* and *tentative*. "Specific frictional requirements need to be determined for each given set of road, vehicle, operator and weather conditions," they say.

The complexity of the slipperiness problem implied in that statement is further underscored by Kummer and Meyer. From the technological standpoint, they say, the problem appears amenable to solutions which are based on:

- . Better geometric layouts of highways;
- . Better pavement design and maintenance procedures;
- . Improvements in the design of tires and vehicles;
- Rigid inspection procedures that keep vehicles with smooth tires and faulty brake, steering and suspension systems off the road; and possibly
- . The adoption and enforcement of different speed limits for dry and wet conditions as well as for day and nighttime driving.

"How much of these possibilities can

be implemented, and how soon, is as much an economic problem as it is a technical one," say Kummer and Meyer. In their report, they deal with both the technical and economic aspects of skid-resistance requirements.

They discuss the causes of pavement slipperiness, the mechanisms of rubber and tire friction, friction-measuring techniques and the correlation among pavement friction testers. These technical considerations are aimed at discovering whether it is physically possible to match the frictional demands of traffic in every situation.

Kummer and Meyer point out, however, that economic constraints limit the possibilities of technical solutions. While skidding accidents (and their costs) decrease as the friction level increases, the cost of skid resistance, say Kummer and Meyer, are that inherently skid-resistant aggregate costs more, the hauling cost is usually higher, and the prescription of high minimum friction levels results in the need for more frequent surfacing.

The researchers go on to investigate the frictional needs of traffic, and then to explain the derivation of their skid resistance requirements. They give suggestions on how a state can implement the minimum requirements.

In the report's final chapter Kummer and Meyer explore ways in which the minimum skid resistance requirements they have derived may be refined. They detail the steps that would assure better use of existing pavement friction levels, the upgrading of these levels and the reduction of the frictional needs of traffic.

REWRITTEN CONSTITUTION AND BY-LAWS ACCEPTED

Twenty-nine percent of the eligible voting membership of the Society returned a total of 452 affirmative votes to accept the rewritten Constitution & By-Laws which were published for the inspection of the membership in the February edition of the SCANNER. The closing date for balloting on these documents was previously fixed as March 31st. Two negative votes were cast. A total of 1518 members were eligible to vote and twenty percent of the eligible voters was required, with an affirmative vote of two-thirds of the ballots necessary for passage. The national Board of Directors officially adopted the rewritten documents at a meeting on April 19th and this instrument became effective on that date. All Society sections will now be required to prepare and submit a set of by-laws governing their own units, and consistent with the national Constitution.

INSPECT PIKE SPANS

Creation of a new unit responsible for the inspection and maintenance of all bridges on the Pennsylvania Turnpike has been announced by Commission Chairman Lester F. Burlein who said the unit's purpose was twofold: to make "periodic inspections of all bridges and at the same time keep the road surfaces on the bridges up to the high standards we require on our entire turnpike."

With the advent of spring, Burlein said the unit's work would be intensified to check all spans on the toll road for pos-

sible winter damage.

The bridge unit will be under the direction of G. Edward Swartz, a York County engineer and a past president of the American Society of Highway Engineers. The bridge staff will consist of a foreman and three men assigned to each of five districts, or a total of 20 men.
