Anthony J. Gaeta, P.E., Pittsburgh District Engineer for the Pennsylvania Department of Transportation, has been elected 1975-76 President of the Pittsburgh Section of American Society of Highway Engineers.

"Tony" Gaeta, as he is affectionately called by his friends and associates, has been in the Pittsburgh district since April of 1969, serving initially as Assistant District Engineer for Locations and Design. He was transferred to Pittsburgh from Harrisburg where he had been Assistant Director of PennDOT's Bureau of

Planning and Statistics.

On July 22, 1970, "Tony" was named Pittsburgh District Engineer, to fill the post that was vacant since June 1969.

Victor W. Anckaitis, PennDOT's Secretary at that time, aptly labeled Anthony Gaeta a man with broad experience in both private and public sectors, as the person most qualified to wrestle and solve the awesome transportation problems in the Pittsburgh area.

Gaeta came to the Department in April 1968, following a five-year period with a New York City consulting firm during which time he was deputy director of three regional transportation studies for total transportation planning and land utilization in West Virginia and Massachusetts.

While with the consulting firm of Tippetts-Abbett-McCarthy-Stratton, Gaeta was assistant resident project director for the South-eastern Massachusetts Regional Transportation and Arterial Study and in West Virginia was in charge of the highway phase of a regional traffic and arterial study.

A civil engineering graduate of Tri-State College, in Angola, Indiana, Gaeta qualified for his new post following State Civil Service Commission certification. He also holds an advance degree in traffic engineering from the University of Pennsylvania.

Gaeta, who has been an engineer for 21 years, is a registered professional engineer in the Commonwealth of Pennsylvania and in the States of New Hampshire and Massachusetts.

In Pittsburgh he has been Chairman '72-'73 of the urban development and transportation group of the Pittsburgh Section of the American Society of Civil Engineers. Nationally he holds membership in the Institute of Traffic Engineers, the Highways Research Board, National Society of Professional Engineers, American Society of Civil Engineers, American Society of Highway Engineers, Society of Military Engineers and Pennsylvania Society of Professional Engineers.

He is a former Director and is presently Vice-President of the Society of American Military Engineers; Director for 2 years of the American Society of Civil Engineers; former Chairman of the Urban Development and Transportation Committee of ASCE.

The Pittsburgh Section is indeed fortunate to have as its president a man with an intensive and impressive professional background.

In spite of the tremendous and timeconsuming responsibilities of his position as PennDOT's Pittsburgh District Engineer, "Tony" Gaeta can still muster up the effort to put together a very able and diversified committee to head up the various programs scheduled for the coming year. 

mestic petroleum use, automobiles use only 29%.

Of the total gasoline used in highway travel, 63% is used by private cars; the balance is used by trucks, buses, and by business and government vehicles.

42% of automobile travel is related to earning a living; 19% is for family business (shopping, medical visits, etc.); 5% is for civic, educational and religious purposes; only 34% remains for social, recreational and miscellaneous travel.

LEGISLATIVE NEWS

The report is not intended to be comprehensive and all-inclusive of bills that may be of interest to ASHE and the varied interest of our members. It does, however, pinpoint some specific legislation that may be of interest to many members.

The report is just that, a report that legislation was introduced, a short title contained in the legislation itself, and a status report of action, if there is one. Harrisburg Section started this report in our monthly "Profile" hoping that interested members will contact their elected legislator or state senator if they wish to know more about the legislation.

The main source of my information is "The Scene" published by the Associated Pennsylvania Constructors and a status report compiled by the Legislative Coordinator of PennDOT.

In the 1975-76 Session of the Legislature, about 900 Bills have been introduced in the State Senate. Over 1500 Bills have been introduced in the State Legislature. Many of these deal with topics that are of specific interest to ASHE members.

At this writing, NO Capital Budget Act for fiscal year 1975-76 has been introduced. This Act will provide a new authorization for PennDOT to borrow money to finance their construction program. All projects that are let this year have utilized money from prior years authorizations. If PennDOT is to continue to bid new projects and make payments on current projects, a Capital Budget Act for 1975-76 is mandatory.

No fewer than 24 different pieces of legislation have been introduced in the State legislature that would exempt favored groups from paying gasoline taxes and highway use taxes. These bills are being introduced as a means of circumventing the Constitutional provision of a uniform tax on the highway user for designing, constructing and maintaining highways. At least 11 bills have been introduced in the State Senate for the same purpose.

BILLS INTRODUCED IN THE SENATE:

*SB-803 amends the Vehicle Code to require PennDOT to provide a means of noting on a driver's license the intent of the licensee to be a donor of body organs or parts. APC OPPOSES THIS because such information is not properly under the jurisdiction of PennDOT, and the bill makes no provision for the added costs

thus incurred.

(Senators Fleming, Dougherty, Coppersmith, Howard) JUne 10, 1975; Committee: Transportation.

*SB-805 provides a deficiency appropriation out of the General Fund to the Port Authority of Allegheny County in the amount of \$5.2 million.

(Senators Nolan, Scanlon, Noszka, and Early) June 10, 1975; Committee: Appropriations.

*SB-815 transfers responsibility for urban mass transit assistance from the Department of Community Affairs to PennDOT; redefines certain operations.

(Senators Smith, Manbeck, Lynch, Kelley, Duffield, et al) June 11, 1975; Committee: Transportation.

*SB-817 is similar to SB-803 and poses the same objections.

(Senators Dwyer, Stauffer, Orlando, Stapleton, et al) June 11, 1975; Committee: Transportation.

*SB-818 regulates the awarding and execution of certain public contracts. Full details covered in APC Legislative Bulletin No. 12, Page 1, and supplement.

(Senators Scanlon, Nolan, Ewing, Dwyer, Ammerman, et al) June 11, 1975; Committee: State Government.

*SB-819 excludes volunteer fire, ambulance and rescue companies from fuel use tax.

(Senators Andrews, Dwyer, Ross, Lynch) June 11, 1975; Committee: Finance.

*SB-820 exempts volunteer fire, ambulance and rescue companies from liquid fuels tax.

(Senators Andrews, Dwyer, Ross, Lynch) June 11, 1975; Finance Committee.

*SB-823 itemizes appropriations out of the Motor License Fund to other Departments for fiscal 1976, in the amount of \$208,500,000.

(Senator Cianfrani) June 16, 1975; Appropriations Committee.

*SB-826 makes editorial changes to the Workmen's Compensation Act.

(Senator Cianfrani) June 16, 1975; Labor and Industry Committee.

*SB-828 authorizes PennDOT to establish bicycle lanes. Appropriates five million dollars out of General Fund.

(Senator Early) June 16, 1975; Transportation Committee.

*SB-840 further defines lobbyists.

(Senators Howard, Frame, Hill, O'Pake, et al) June 17, 1975; Rules and Executive

Nominations Committee.

*SB-853. This is the "Penna. Noise Control and Abatement Act." Similar to legislation introduced in the previous session. Too restrictive. Detailed analysis will follow.

(Senators Mellow, Nolan, Holl, Kelley, Frame, et al) June 18, 1975; Environmental Resources Committee.

*SB-858, known as the "Motor Fuel Distribution Control Act" this bill sets up the limitations and restrictions on the sale of liquid fuels, including promotions, etc.

(Senators Reibman, Nolan, Smith, Arlene, et al) June 18, 1975; Labor and Industry Committee.

*SB-860 requires all Commonwealth agencies (including PennDOT) to furnish copies of contracts to the Legislative Data Processing Center.

(Senators Tilghman, Fleming, Messinger, Cianfrani, et al) June 18, 1975; State Government Committee.

*SB-878 adds a route in South Madison Township, Perry County, to the state highway system.

(Senator Moore) June 18, 1975; Transportation Committee.

*SB-880, deficiency appropriation of \$5.2 million to the Port Authority of Allegheny County. (Same as SB-805).

*SB-888 expands PennDOT's authority and responsibility for roadside plantings, and places restrictions on the public. GOOD BILL.

BILLS INTRODUCED IN THE HOUSE:

*HB-1449 provides that all agencies of state government (including PennDOT) must hire one welfare recipient "ready for employment" for every non-recipient hired.

*HB-1457 imposes a tax on severance of minerals by surface mining method, at rate of 15 cents per ton. APC HAS EXPRESSES STRONG OPPOSITION.

*HB-1469 authorizes volunteer fire companies to bill certain owners or operators of motor vehicles on interstate highways for services rendered and provides for liens against such persons in the case of nonpayment; provides legal representation for volunteer fire companies in such cases. THIS HAS APC'S SUPPORT.

*HB-1492 increases the number of members of the Transportation Commission by TWO, both from the aviation sector.

*HB-1499 exempts "any third class city port authority" from liquid fuels tax.

(Mr. O'Connell) June 17, 1975; Transportation Committee.

*HB-1500 authorizes PennDOT to restrict use of certain streets within municipalities.



*HB-1507 increases penalties under the "Motor Carrier's Road Tax Act" for failure to obtain and affix vehicle identification stickers.

*HB-1510 provides for six-month registration of trucks in classes 15 through 20, at one half the annual fee.

*HB-1522 increases the millage from 14 to 17 for road, bridge and general township purposes.

(Messrs. Fryer, Mebus) June 23, 1975; Local Government Committee.

*HB-1527 provides that Penna. and New York pay all the costs of building ramps and approaches in the respective states to bridges over the Delaware River.

(Messrs. Bonetto, Lederer, Arthurs, George, et al) June 24, 1975; Transportation Committee.

*HB-1528, similar to HB-1527.

(Messrs. Bonetto, Lederer, Arthurs, George, Beren) June 24, 1975; Transportation Committee.

*HB-1531 allows non-registered farm equipment to travel 20 miles over roads instead of the 8 miles present limitation.

(Messrs. Pyles, M.E.Miller, Jr.) June 24, 1975; Transportation Committee.

*HB-1533 sets up cyclical motor vehicle registration system over 10 month period; raises vehicle registration to \$20; increases truck registration fees by limited scale across the board. NOTE: While this would provide some additional revenue into the Motor License Fund, it is insufficient to even come close to meeting

highway needs.

*HB-1539 adds a route in South Madison Township and Tyrone Township, Perry County, to the state highway system.




TRANSPORTATION WEEK
