The award was presented to Graham in recognition of his many contributions to the highway industry.



# Franklin

Summertime is the time for doing "one of a kind" things and the people who live in the Marienville area of Pennsylvania can plan ahead to make the summer of 1984 a "Helistat Summer". That invitation was issued at the April ASHE meeting when Bob Seybert introduced Al Flecksic, District Forest Ranger at Marienville.

A helistat is a dirigible with four helicopters attached to the bottom of it. The dirigible is used to lift timber the weight of the helicopters and the helicopters are in turn used to lift timber from the forest floor. The object of the complicated "junkyard contraption" (as Al put it) is to be able to move a 26 ton load of lumber from otherwise inaccessible areas of forestland. The forest service owns some six billion board feet of this type lumber and, in addition, it is hoped that the helistat can be used for such jobs as fire fighting, fertilizing and power line clearance; as well as disaster relief transport.

The 20 million dollar project will move into the Buzzard Swamp area in July of 1984, the timber will be harvested and sold at the helistat landing. The public is being invited to view this "one of a kind workhorse" and to participate in the timber sale. Anyone desiring more information may contact Al Flecksic.

Although it was not a scheduled part of the program, ASHE members asked Ranger Flecksic why the forests in the area are being "clearcut", producing unsightly areas. Al explained that the hardwoods most needed will not reproduce in shaded areas, therefore, all growth must be taken. Even though Flecksic agreed that clearcut is unsightly, he stressed it is important to insure that the hardwood lumber areas do not just "cease to exist" while the forestry has to play "catch up".











Following a question/comment period, the meeting was adjourned.






