

Link Replaced in Allentown



BEFORE: Original structure, built in 1924, was structurally and functionally obsolete. The massive piers of the bridge also detracted from the visual quality of this scenic recreational park.



AFTER: New Susquehanna Street Bridge blends harmoniously with park surroundings and provides an open effect with longer spans and flowing lines of piers and curved steel superstructure.

An aging and massive ten-span viaduct has been replaced by a gracefully - sweeping four-span curved steel beam bridge in Allentown, PA, to reestablish a key transportation link to the center of the city. Known as the Susquehanna Street Bridge, this new structure with clean and open lines connects two parts of Allentown, replacing a cluttered and deteriorated crossing of the scenic Trout Creek Park. Functional piers with flared caps and artistic rustications blend harmoniously into the wooded setting. The superstructure is continuous over its

282 foot length and creates little distraction to the eye of hikers, bikers, and fishermen who regularly utilize the upgraded recreational area. Structural connections which are visible from below the bridge were detailed for smooth stress flow to enhance fatigue strength, and at the same time have resulted in a pleasing visual effect.

The new bridge removed a ten-ton load restriction which had required heavier trucks and busses to take a winding detour route, which included the hazards and delays of an at-grade railroad crossing. The new bridge opened in October, 1989, just fifteen months after the start of construction. It was followed in just a few month by the completion of nearby Interstate Route 78. Visitors and local residents alike have welcomed the opening of the new Susquehanna Street Bridge for the improved traffic corridor that it has afforded.

Owner of the \$2.2 million bridge is the City of Allentown. Engineers were the firm of McTish, Kunkel & Associates, and the General Contractor was H.J. Williams, Inc.



D'Alba Attends Meeting of Pennsylvania Engineering Societies



Dear Steve:

I appreciate the opportunity you afforded me in allowing me to partake in the referenced meeting held at the Hershey Country Club on October 26, 1990. Through this letter I hope to give you a brief summary of what took place. The stated goal of this meeting was to explore opportunities where the Engineering Societies can work together on common concerns and issues.

The Engineering Societies were represented by ASCE, PA Consulting Engineers Council, IEEE, PSLS, PSPE, ASME, and of course, ASHE, through Bob Rogers and myself, and indirectly, Al Kozel, who was representing CEC of Pennsylvania. An attendance list will be mailed to me shortly, at which time I will forward a copy to you for your information.

Each organization was well represented by active members in their society. The meeting, while informal in nature, followed an ambitious agenda which covered many subjects including:

I. Legislative Concerns.

II. Certification for Pre and Post-Registration.

III. Continuing Education.

IV. Undergraduate Education.

V. Engineering Shortage.
VI. Licensing the European
Community by Reciprocity.

VII. Academic Registration.

VIII. Overhead.

IX. Liability.

Each of these topics was discussed at length and, in summary, I offer the following highlights of each topic:

• Legislative concerns:

A joint legislative committee representing many of the groups present in

On Oct. 26, 1990, Edward M. D'Alba, P.E, President of Urban Engineers Inc. (see "As The Wheel Turns") attended a meeting of Pa. Engr. Societies on behalf of ASHE and at the request of President Lester. The National Board wishes to extend their sincere thanks to Mr. D'Alba for his willingness to set aside valuable time to attend, participate, and report on the meeting. Following is his letter to Pres. Lester, in it's entirety:

the room has been formed, yet unfortunately has received minimal interest. Jack Seeley, who heads this committee through PSPE, stated that, unfortunately, legislative issues which directly relate to us, probably more so than any other issue facing the engineering community, seems to be a low priority in the engineer's mind, in contrast to the support the Societies receive for things such as scholarships, engineering competitions, and technical information exchanges. He pointed out that enactments of the legislature affect our profession more so than any other single issue related to the engineering profession. He also stated that in many respects we are a victim of the system because we are not able to effectively get legislature enacted that would recognize, respect and protect the engineering community at large.

Certification for Pre and Post-Registration

The group shared a common concern that there is too much emphasis on additional certification and pre and post- registration of the professional engineer. There was a consensus that society is losing sight of the fact that engineers are qualified, trained and licensed to do many things that are now being certified by new certifying agencies that tend to represent only a small segment of work that could and should be considered the domain of the professional engineer. Examples include house inspectors, radon inspectors, asbestos certifications, etc.

Continuing Education

The continuing education concept, while being strongly supported by the land surveyors represented in the room, was generally considered by the consensus in the room to be ineffective and not something that we want to see mandated for the profession. The concern of the young engineer in wanting to move through his organization and the concern of the seasoned professional in wanting to protect and minimize his liability, is believed to be a strong motivating factor that encourages engineers to stay abreast with changes and innovations in their field.

• Undergraduate Education/Engineering Shortage

A lengthy discussion was held on the status of the education of engineers. All agreed that the quality of the engineering graduate is not what it once was, and it certainly is less than what we would consider acceptable to maintain the professional standards which we in the profession try to represent. Suggestions as to the cause of the problem were diversified. Problems pointed out included the inability of the profession to attract the talented individuals because of: 1) lack of competitive salaries in some of the engineering fields, in particular, civil; 2) poor professor/student contact because of language barriers that seem to be becoming more pronounced as the colleges are retaining more foreign- speaking professors; 3) lack of awareness as to what an engineering career is and what it can lead to regarding personal (nonmonetary) satisfaction; and 4) the unwillingness of those that practice in engineering to spread the words to their relatives, friends and neighbors that engineering is a field that they would personally recommend to a young, bright student considering getting into the profession.

Overhead

It was agreed that one of the concerns the community has on the corporate overhead limitations needs to be continuously addressed because it unfairly limits engineers from performing their services, assuming associated risks, and being allowed to receive a reasonable profit for services performed.

It was noted that PADOT, being the largest employer of engineers in the state, in both a primary and secondary capacity in awarding of contracts to consultants and contractors, has set a standard of overhead that permeates the State which is considered by many present in the room to be unfair. Examples given were the fact that PADOT has an artificially low maximum salary allowance which artificially lowers their recognized overhead of firms and in addition, PADOT disal-



lows other costs that are normally acceptable and permitted by other agencies, primarily federal agencies, that would allow the engineering community to receive a fair overhead.

It was recognized by those agencies represented that do not work directly for PADOT that they too have a concern in the rules that the Department has imposed because many other users of engineering services tend to follow the rules and mandates of PADOT.

Liability

Concerning liability, the group was notified of the recent phenomena occurring in a Philadelphia market wherein the legal professional has identified opportunities for workers and their families injured and/or killed in a contractor related accident to sue the third parties involved with the work and, in numerous situations, collect substantial awards through out-ofcourt settlements by sued third parties. Fortunately, legislation has been enacted in seven or eight states nationwide to prevent this problem from reoccurring and it was most recently introduced in the state of Georgia. CEC is working with PADOT to try to get similar legislation enacted in Pennsylvania which will protect the design professional, construction inspector and the construction manager involved with projects that have exposure to worker's claims related to Workman's Compensation injuries.

All in attendance agreed that the exchange of information and sharing of ideas was quite beneficial and should continue in the future. To start, each of the represented agencies will be sending to each other information they may have that they think would be beneficial for the other societies to be aware of and for them to, at their discretion,

distribute to their membership. And secondly, because of the pressing theme as to the problem with attracting people into the engineering profession and the quality of education, it was agreed that we would convene some time early in 1991 and invite the

deans of the major engineering schools in the state to be present for a round-table discussion as to problems that we perceive, the problems they perceive and common solutions to achieve better quality engineering in the state of Pennsylvania.

In closing, Steve, I want to thank you for the opportunity to represent you at this meeting and in the event I can be of any further assistance, please advise.






