- Training Update: Richard N. Cochrane, PE
  - o President Cochrane reported on the Section Officers training. A summary of the questions and attendance is attached to these minutes.
  - Training was successful with overwhelmingly positive comments. Improvements will be made to the presentation for next year based on feedback received.
  - The Power Point file has been forwarded to the Technology Committee for posting on the National Website.
- Administrative Assistant Update: Michael D. Hurtt, PE
  - Committee Recommendation: Michael D. Hurtt, PE
    - Mr. Hurtt reported that six candidates had applied for the Administrative Assistant position.
    - Nancy Morisi was ranked first by all committee members with the exception of Mr. Morisi who abstained from ranking Ms. Morisi but ranked the other candidates.
    - Mr. Hurtt will present a recommendation to hire Ms. Morisi at the January National Board Meeting with a February 1, 2019 date.
    - A pay rate has not been discussed but will be included with the recommendation. The position is an average 30 hours per week with no benefits.
  - Computer and Related Items for Administrative Assistant: Thomas S. Morisi
    - Mr. Morisi presented a quote from Link Computer Corporation for the purchase of a new laptop to include a docking station, on-site service agreement, Microsoft Office Suite, and Adobe Acrobat. The quote totaled \$2,308.00. A monitor and keyboard will be purchased separately.
    - Since funds related to the Administrative Assistant position, the Committee agreed to proceed with the purchase.
- Website: Richard N. Cochrane, PE
  - O Mr. Cochrane reported that the deadline for responses to the RFP for a new website has been pushed back to December 5, 2018 due to a need to remove language from the Request for Proposal that eliminated most of the proposers that could submit.
- Budget President's Travel Money: Michael D. Hurtt, PE
  - Mr. Hurtt reported that the National President is traveling a great deal and will exhaust the travel amount budgeted. He will be seeking approval to increase the travel budget and expressed his support of the President reaching out and visiting Sections.
  - o Mr. O'Hare noted that Directors are not charging for travel to Sections and expressed concern they may not be visiting Sections as intended. Mr. Harris recommended a change to the Sections Reports to note if a Director attended a meeting and who that Director was. President Cochrane will remind Ms. Stuttler to continue to solicit meeting attendance from Directors. Mr. Hurtt suggested that it be part of the nominating process that Directors have the ability to travel.



- Insurance: Richard N. Cochrane, PE
  - Mr. Cochrane reported that he has received some email correspondence from Mr. Brad Bush with DesignPro Insurance Group (our current provider) and is attempting to obtain a quote from them. Mr. Cochrane will be back in touch with Mr. Bush to obtain a quote.
- Audit Results: P. Frank O'Hare, PE
  - o Mr. O'Hare reported that the audit is complete and reflects a positive audit.
  - National realized a loss in assets of approximately \$11,000 due to two conferences being held in one budget year and no revenue was realized from the NY Conference.
  - o YTD, our investments have lost approximately \$20,000.
- January National Board Meeting: Thomas S. Morisi
  - Mr. Morisi reminded the Committee that the National Board Meeting will be held on January 11<sup>th</sup> and 12<sup>th</sup> at the Embassy Suites by Hilton Phoenix Airport.
  - The Board Meeting will be held on Friday (1/11) from 3:00 to 5:00 and on Saturday (1/12) from 7:30 to 11:30. Additional information will be sent out prior to the meeting.
- IRS Late Fees: Michael D. Hurtt, PE
  - Mr. Hurtt noted that he received an email from the IRS regarding late fees. ASHE
    National received a penalty in North Carolina for a late filing. The late filing was
    due to a mailing issue between our CPA and the Treasurer.
- ASHE National Official Address: Richard N. Cochrane, PE
  - The ASHE National Address is to change from Beacon Hill to Mr. Morisi's home address. A motion is to be made at the January Meeting establishing a deadline for the change.


