DISCUSSION:

Branding

President Matthews stated that ASHE, as an organization, does not do a good job in getting the word out on all that ASHE has to offer. The slogan "The Transportation Industry's Premier Networking Organization" is very prominent on our website. However, the mission statement is less prominent but spells out what ASHE is about. We need to develop strategies on how to promote the mission of ASHE and we need input from all National Board meeting participants. A discussion will be held at tomorrow's National Board Workshop and President Matthews' goal is to encourage participation by all in attendance.

National Board Expense Policy & General Information Guidelines for Board Members

Secretary Morisi presented a revised National Board Expense Policy which reflected the following changes:

- Item 4: The language was changed to remove a specific mileage rate and provide a "rate as established by the National Board and recorded in the board meeting minutes"

Following Governing Documents

Secretary Morisi noted that, throughout the organization, there seems to be a lack of knowledge in the governing documents such as the Constitution and Bylaws.
